You have to write 10 pages excluding references, tables and figures, 12pt, 1.5 spaced. There is no claim that the reading list is complete, it is intended to give you a good start, but most probably you will need additional literature that is not listed. The file of your presentation is due two days before the seminar. Please also send pdf versions (and ppt/pdf in case of the presentation) to Florian Johannsen. In order to get a topic, you have to register in Stud.ip after the 1st of March and choose a topic in the forum by answering to the corresponding thread. It is first-come, first-served and every topic is available for two students.
